



## 2023 Woman Entrepreneur Award

**Criteria:** Nominee must be a female who owns/operates a business that has functioned for at least three (3) years and generates a minimum of \$5,000 gross revenue annually. The business must make or sell a product or provide a quantifiable service. Franchise owners are not eligible for this award. WCW board members are not eligible for the award while serving on the board. The deadline for 2023 nominations is April 30, 2023.

### **Nomination:**

1. Nominee may nominate herself or be nominated by another individual.
2. In addition to the name, mailing, and email addresses of the nominee, WCW requires a description of the business that includes its location and the product or service provided.
3. Please include both a summary of the nominee's education, training, background, community service/ involvement, and a picture of her at her business.
4. Signed release for the use of the picture and information on WCW media (see nomination form).
5. WCW requires a statement from the entrepreneur which details the benefits and challenges of establishing a business in Wyoming.
